Guardianship, therefore, is the legal relationship between a guardian and the ward (the person in need of a guardian). Anyone planning to file for a guardianship for a loved one, or to become a guardian themselves, must gather certain documents, such as medical records and receipts showing the ward's expenses.

State Guardianships Forms - FindLaw

To be a legal guardian you need an order from the court. Living with a child or incapacitated adult does not make you their legal guardian without a court order. It is always best to get an attorney, and sometimes the court will require you to have an attorney in a guardianship case.

file using eFile & eServe (eFS), mail, or deliver to the probate court where your case is filed. If you do not submit your documents on time each year, you may be required to attend court and explain why to a judge.
