Refusal of work. (en español) Individuals receiving unemployment benefits must be able and available for suitable work, this includes an offer to return to work after being laid off due to COVID-19. People receiving unemployment benefits must have a good-cause reason not to accept an offer to return, in order to continue receiving benefits.

ESDWAGOV - Refusal to work

Not returning to work when there is available work could be considered a "refusal of work" or "voluntary quit" and potentially disqualify claimants from receiving reemployment assistance (unemployment insurance) benefits, including the Federal Pandemic Unemployment Compensation benefit of \$600/weekly.

Reemployment Assistance Benefits - Refusal to Work

Workers have the right to refuse unsafe work. If you have reasonable cause to believe that performing a job or task puts you or someone else at risk, you must not perform the job or task. You must immediately notify your supervisor or employer, who will then take the appropriate steps to determine if the work is unsafe and remedy the situation.

More Canadians are refusing work due to COVID-19 — but it ...

This document is about the right to refuse dangerous work. It aims to inform employees, employers, members of the work place committee, and occupational health and safety representatives of their legal rights and obligations when an employee exercises a refusal to work under Part II of the Canada Labour Code (Code).

Right to refuse dangerous work - Canada.ca

Section 402 (a) of Pennsylvania Unemployment Compensation Law provides, in part, that an employee shall be ineligible for compensation for any week in which their unemployment is due to failure, without good cause, to accept suitable work; provided that the employer who offers the work notifies the department of the refusal within seven days from when the offer is made.

UC-1921W Refusal of Suitable Work

When a claimant works under a contract of hire (either written or verbal), the claimant's work expires when the specified period of work ends. Since the claimant in effect has been laid off, refusal of an offer to renew the contact, whether made on, before, or after its expiration, is a refusal of new work.
